## HOURS OF OPERATION

Camp hours are from 7:30 a.m. until 6:00 p.m., June 10, 2024, through August 9, 2024. There is a **\$10 daily charge** for any child who is picked up after 6:00 p.m. This charge must be paid on that day or at the beginning of the following week. If the fee is not paid, it will be added to the next week's fee. We reserve the right to deny your child access to camp because of nonpayment of late fees.

## DROP-OFF/PICK-UP

Drop-off/pick-up will take place at the lobby entrance of the Church. If you are dropping off after 9:00 a.m. or picking up before 5:00 p.m., please gain access to the building by ringing the office entrance doorbell at the south side of the building.

## DRESS CODE

Campers should wear comfortable clothes for the summer weather, t-shirt, shorts, socks and sneakers. Inappropriate dress such as clothes that exposes the midriff, clothing with offensive language or symbols, flip-flops and sandals should not be worn. It would be a good idea to send a change of clothing for the younger campers. All clothing **MUST** be marked with the child's name. **Camp ChristWay T-shirts must be worn on ALL field trips - no exceptions. Campers WILL NOT be allowed on trips without their Camp ChristWay T-shirt.**

## CONDUCT

All campers must always follow the Code of Conduct. Disobedience, fighting or the use of offensive language will not be tolerated and will result in suspension. A second offense could result in expulsion. Please review the Code of Conduct with your child and return a signed copy with your completed application.

## HEALTH

Health forms are a requirement for all campers. Please return health forms with the completed application. Our policy is not to administer medication. **If your child has a fever or any other illness, please keep your child home. If your child becomes ill, you will be contacted to pick up your child.**



## **SAFETY**

**Children will not be given to anyone who is not listed on their registration form. These individuals must provide a picture ID to pick up your child.** You are required to sign your child in and out of camp daily. Children will not be accepted into their classroom without a pass from the Sign-in Desk.

## **LUNCHESES**

ChristWay is a participant in the Summer Food Service Program (SFSP) sponsored by the Florida Department of Agriculture and Consumer Services Division of Food, Nutrition, and wellness. As a Church we are committed to ensuring that **all** campers are provided with a hot meal and an afternoon snack daily. A copy of our monthly lunch menu will be provided to all parents. Therefore, we ask that you notify us of any food allergies your child (ren) may have.

## **CELL PHONES AND OTHER TECHNOLOGY DEVICES**

Children are encouraged to use their devices during Camp hours. If they take a phone to camp, it must be kept in their bag. Camp ChristWay or ChristWay Baptist Church does not assume responsibility for any technology equipment that the campers bring to camp that may become damaged, misplaced, or stolen.

### **Bring Your Own Device (BYOD) to Camp**

Camp ChristWay is committed to aiding campers and staff in creating a 21<sup>st</sup> century learning environment. Recognizing that technology has become an integral part of our learning process, ***Camp ChristWay has modified its procedures to allow our campers access to personally owned devices during camp for educational purposes only.*** A personally owned device shall include all existing and emerging technology devices that can take photographs; record audio or video; input text; upload and download media; and transmit or receive messages or images. Campers are not allowed to bring gaming devices or consoles, laser pointers, modems, or routers.

Personally owned devices are permitted for use during the camp day for educational purposes and/or in approved locations only. Educational purposes include classroom activities and limited high quality self-discovery activities.

Campers are not allowed to use their personally owned devices for inappropriate communication which includes, but is not limited to: obscene, profane, lewd, vulgar, rude, inflammatory, threatening, or disrespectful language or images typed, posted, or spoken by students; information that could cause damage to an individual or the camp community or create the danger of disruption of the academic environment; personal attacks, including prejudicial or discriminatory attacks; harassment (persistently acting in a manner that distresses or annoys another person) or stalking of others; knowingly or recklessly posting false or defamatory information about a person or organization; and communication that promotes the destruction of property, including the acquisition or creation of weapons or other destructive devices. If a camper is told to stop sending communications, that camper must cease the activity immediately.

Campers may not utilize any technology to harass, threaten, demean, humiliate, intimidate, embarrass, or annoy other campers. This is unacceptable camp behavior known as cyber bullying and will not be tolerated. Any cyber bullying that is determined to disrupt the safety and/or well-being of the camp is subject to disciplinary action.

Campers must be aware of appropriateness of communications when using personally owned devices. Inappropriate communication is prohibited in any public messages, private messages, and material posted online by campers.

Campers are not permitted to use any electronic device to record audio or video media or take pictures of any student or staff member without their permission. The distribution of any unauthorized media may result in discipline including but not limited to suspension, or expulsion.

Personally owned devices used in camp are not permitted to connect to the Internet through a 3G, 4G, or other content service providers. Personally owned devices must access the internet via the Church content filtered wireless network.

Campers who choose to disregard use and expectations requirements will temporarily lose the privilege of utilizing personal devices in camp.

It is important to note that similar to other personally owned items, Camp ChristWay is not liable for the loss, damage, misuse, or theft of personally owned devices brought to camp. It is the responsibility of each camper to ensure their devices are properly identified and secured when not in use. Each camper agrees to take full responsibility for his or her device, by always keeping it with himself or herself. The camp is not responsible for the security, theft, damage, or loss of the device.

The camp reserves the right to inspect a camper's personal device if there is reason to believe that the camper has violated Camp rules, administrative procedures, or has engaged in other misconduct while using their personal device.

All campers shall review this policy and associated technology guidelines before utilizing their personally owned devices. The Camp reserves the right to restrict campers use of personally owned devices on Church property.



## **ACCOMMODATING CHILDREN WITH SPECIAL NEEDS**

Camp ChristWay offers an interactive program that supports children's growth and learning through the provision of an intentionally planned and developmentally appropriate environment. While Camp ChristWay offers exciting fun and play, Camp ChristWay encourages continuous learning through our summer literacy and science program. Our structured environment provides each child an opportunity to explore, create and problem-solve while enjoying his or her summer vacation. Classrooms are organized around interest centers and play areas that include art, math, science, language arts, and nutrition.

Camp ChristWay's staff plans and facilitates these experiences for the total development of each child. While we strive to accomplish these goals, we recognize that educating children with special needs and/or disabilities is a modern-day challenge. Although we firmly believe that you cannot separate childcare and education, Camp ChristWay does not offer special education or special needs services, especially since not all of our teachers and/volunteers have a background or experience in working with students with special needs. While we hire teachers who both work with and are interested in working with children in an integrated environment, we promote quality learning and play for all children and will work collaboratively with families to ensure a successful summer camp experience.

As such, we accept any child who does not pose a direct threat to others and whose needs we can meet without putting an undue burden on the camp, its teachers, participants, or fundamentally altering the program, service, or operation.

## **SUMMER CAMP COST**

Camp fees are due on Monday morning of each week. Campers wishing to attend on a daily schedule **MUST register at least 24 hours in advance.** Admittance to camp for campers wishing to attend daily will depend on available space and will be accommodated on a first-come, first-served basis.

### **FAMILY DISCOUNT**

**\$140.00** is the weekly rate and **\$130.00** for each additional child in the immediate family. No discount is being offered on the daily rate.

### **ADVANCED PAYMENT DISCOUNT**

A FREE week is given when payment for 8 weeks is paid in advance.
